ENTRY INFORMATION

All entries must be submitted with an official CFA entry form, printed or typed clearly. Incomplete entry form will NOT be accepted and will be returned to owner/exhibitor.

All cheque must be drawn on HK banks and in HK funds. Please make cheque payable to **PNECC Limited**. Overseas exhibitors should bear all bank charges.

Only ONE benching request will be attempted to be honored whenever possible.

There will be a HK\$500 fee charged for returned cheque for any reason.

Fax, registered and courier entries are not accepted. **Snail mail & email entries only. No other entry method will be accepted.** As per show rule 11.08a, each entry must be accompanied by the entry fee. A surcharge of HKD200 is applied to each email entry. All entries (local or overseas) to be confirmed upon payment received. The club reserves the right to notify CFA Central Office for any unpaid entries and outstanding payment. According to show rule 11.08 b.3, CFA will rescind all wins earned by the exhibitor's cat(s) for that show weekend and suspend all CFA services. Once points are rescinded they will not be reinstated.

Each entry (by snail mail or email) must be accompanied by the exhibitor's declaration and required fee, otherwise the entry will be regarded as incomplete.

Entry clerk will return the entry form to owner/exhibitor if entry information is illegible or incomplete.

Entry fees will not be refunded for failure to bench.

No substitution after August 15, 2011. The club will not be held responsible for any entries not received due to transmission errors.

RULES

This is a vetted show. Please bring along the vaccination and rabies cert along with you.

Cats are expected to be free of fungus, ear mites, fleas and any other infectious diseases. It is requested that all entries to be inoculated by veterinarian registered under the Veterinary Surgeon Board Hong Kong against Feline Enteritis, Rhinotracheitis and Calicivirus within 1 (one) year; rabies at least 14 days and within 3 (three) years. Additionally, all importing entries must provide the rabies certificate issued by the HKAFCD.

Claws of all four feet must be clipped prior to benching. No declawed cats may be entered.

Show Manager reserves the right to cause the removal of any cat from the show hall suspected of any of the above until a licensed veterinarian can make an examination at the exhibitor's expense.

Cats are not allowed to remain in the show hall overnight.

Exhibitors must transport cats into and out of the show hall in an enclosed, secured carrier.

First-time exhibitors should contact the show manager for assistance. We

will try to bench you next to an experienced exhibitor.

All bench entries, with the exception of kittens must remain in the show hall until the advertised closing hour of the show unless permission is received from the show manager.

AWARDS

CFA show rules will be strictly enforced. Ribbons and awards will be awarded for all finals in compliance with CFA show rules.

Designated flats will be used where applicable. Cloth flats will be available upon request.

CFA registered numbers must be included for all championship, premiership and AOV classes.

Kittens must be 4(four) months old by the first day of the show.

All championship, premiership and registered kitten entries will be scored for CFA regional and national awards.

It is the exhibitor's responsibility to check entry confirmation and notify the entry clerk for any errors. A copy of these rules may be obtained by sending US\$7.00 to CFA, PO Box 1005, Manasquan, NJ 08736-1005.

CAGES

No change in assignment will be allowed without permission of Show Management. A single cage approx. 21"x21"x21". A double cage approx 21"x21"x42".

SECURITY CAGES MAY BE USED FOR EVERY TWO ENTRIES OR WHEN DOUBLE CAGE IS PAID. PLEASE INDICATE IF YOU HAVE A SECURITY CAGE ON YOUR ENTRY.

DUE TO THE SPACE LIMIT, WE RESERVE THE RIGHT TO REFUSE ANY DOUBLE CAGE REQUEST. If we cannot accept your double space request, we

will make notification to exhibitors on or before 15 August, 2011 and return the fees on the opening of the show post.

LIABILITY

HKMCC will take reasonable care to safeguard the property of exhibitors. Neither the club, its members nor the facility shall not be liable for any loss or damage. No guard service will be available at night so all cats must be removed for the show hall during the evening hours. Smoking is not allowed in benching areas & the show premises.

OTHER INFORMATION

Litter will be provided (with limited litter pan on first-come-first served). Exhibitors will bring their own water bowl, food and covering for cages sides and floor.

There will be no parking space provided for the exhibitors.

Cats that are not entered in the show are not allowed to enter the show hall during the days of the show.

IMPORTANT

Please remain the tidiness of the show hall and campus. A cleaning fee of HKD500/entry will be charged to exhibitor if the benching area is found messy and dirty.

No smoking is allowed within the show hall and campus.

The club reserves the right to substitute judges in case of emergency.
